

## Code Administrator Meeting Summary

### Key areas of discussion

- The current proposed timelines for both DCP359 and CMP334 were presented and discussed. Although an Ofgem decision on CMP334 is planned to be later than that for DCP359, the respective Workgroup Report for CMP334 and Change Report for DCP359 will be presented to the May Panels for CUSC and DCUSA respectively. The CMP334 Chair noted that following the May CUSC Panel there is minimal risk of anything other than typographical changes to the legal text.
- The Workgroup reviewed the DCP359 and CMP334 responses received during their respective Workgroup Consultations. A summary of all the CMP334 responses can be found with the Workgroup Papers for Workgroups 3 and 4 [here](#). Note the following key points:
  - The majority of respondents supported the Workgroup's proposed definitions (with minor tweaks) of "Single Site", "Final Demand" and "Final Demand Site".
    - However, there were a group of respondents who argued that parties who consume demand for the sole purpose of providing response services to the transmission or distribution network should be excluded from paying the Transmission Demand Residual.
    - One of these respondents issued a request for a Workgroup Alternative to the definition of "Final Demand Site", which the Workgroup discussed on 21 April 2020. There was a split in views and one Workgroup member asked the requester of the Workgroup Alternative to pinpoint that the exclusion should only apply to those who only provide voltage support. *Post meeting note: On 24 April 2020, the request was updated to only exclude those "that exist solely to*

*provide Reactive Power to the Transmission or Distribution Network do not pay Residual TNUoS charges”*

- Further discussion will be required on this to determine if the Workgroup wish to take this request forward. A call will be set up towards the end of w/c 27 April 2020 to progress this ahead of final Workgroup meeting on 7 May 2020.
- There was also discussion on the Certification process that Users would need to follow to show that their “Single Site” is not a “Final Demand Site” and the transitional process to allow parties to review / dispute (should they so wish) their charges ahead of the charging implementation date of 1 April 2022. The legal text will be updated to reflect these discussions.
