### Key areas of discussion

Following previous discussions at the last meeting and via email circulation, the Workgroup met a final time to hold the vote.

A recap of each of the WACMs was provided ahead of the vote and is summarised below:

#### Original

No compensation

#### WAGCM1 (ESO)

Compensation will be apply as will be developed via CUSC and DCUSA later

#### WAGCM2 (ESO)

Compensation re-opener if more than 1 incident in 12 months. Data will be captured

#### WAGCM3 (SSE)

Compensation applies - not tied to consequential mods

#### WAGCM4 (EON)

Original + last resort only applies if ODFM or similar is put in place first

#### WAGCM5 (EON)

WAGCM 1 + ODFM obligation

#### WAGCM6 (EON)

WAGCM 2 + ODFM obligation

#### WAGCM7 (EON)

WAGCM 3 + ODFM obligation
