Key areas of discussion

- GC0154 seeks to provide clarity to stakeholders by incorporating Interconnector ramping requirements into the Grid Code in line with the requirements of SOGL A119. This includes fulfilling both the Compliance and Operational aspects.
- The purpose of this Workgroup was to discuss which options would be covered by the CBA and to review the 2 solutions put forward by the ESO; Dynamic and Static. These options were shared in the previous workgroup.
- The ESO Rep advised the workgroup that a TSO Engagement plan is in place and there is an ENSOE meeting due to take place in August. The ESO expects an update from this meeting mid-September and will share output in the next workgroup.
- The Proposer gave an update to the Workgroup on who would complete the CBA. This is to be completed by an external party. The timescale for this is still to be confirmed and the consultant to be appointed. The workgroup shared their views on the solutions that they would like included in the CBA. There were also views that the CBA should not only cover the solutions put forward by the ESO but also look to cover market-based solutions if this was feasible, noting that it is not always possible to do so.
- The Proposer also discussed the feedback received from the 13th of July email on the Dynamic and Static solutions (which were presented back at the June workgroup meeting) and addressed other concerns raised.
- The Workgroup agreed to have an in-person meeting on **6 October 2022**.
- The Chair advised the workgroup that during the period that the CBA is being carried out, the draft Workgroup Consultation will be shared for feedback from the workgroup.
