### 1. Introductions and Apologies for Absence

5932. Apologies were received from Nadir Hafeez, Michelle MacDonald and Neil Bennett.

### 2. Approval of Minutes from Previous Meeting

5933. The Panel approved the minutes from the meeting held on 29 June 2022 . **(Post Panel note:** The minutes are now available on the National Grid ESO [website](#)).

### 3. Review of Actions

5934. The Panel reviewed the open actions from the meeting held on 29 June 2022 which can be found on the [Actions Log within the Panel Papers](#).

5935. The Panel discussed **Action 5893** and concluded that this action should remain open until further discussions have taken place with MRPL.

5936. **ACTION** RWI to send out meeting invite between NGESO, NGET, SHET, SPT for a follow up meeting post July Panel.

### 4. Authority Decisions

5937. The Chair informed the Panel there had been no Authority decisions on STC modifications, however, decision on **CM078** is expected on 30 November 2022, in line with the associated CUSC Modification **CMP328**.

### 5. STC/STCP Modification Proposals for Panel Decision

5938. The Chair advised the Panel that one new modification had been received for July Panel and invited the Proposer to present.

5939. RWI delivered the presentation on **CM085 – “To Clarify OFTO reactive power requirements at <20% output.”**.

5940. RWI advised the Panel that **CM085** had been presented in draft at June Panel. The ask of the Panel at July Panel was, that **CM085** should follow the Self-Governance Criteria and proceed to Code Administrator Consultation.

5941. Panel members discussed the **CM085** proposal and some concerns were raised. It concluded that whilst the legal text changes are simple, further discussion needs to take place between the ESO and OFTO representatives to consider any impact of the changes. Subsequent to this discussion it is likely that the proposal will be brought back to the September 2022 Panel.

5942. **ACTION** RWI to organise a meeting between NGESO, OFTO and SPT to determine if clarification can be reached/or a workgroup is required to progress this modification.
5943. RWI will provide and update on **CM085** at August 2022 Panel.
5944. Invitation was extended to AJ/SA to present **GC0156 – “Facilitating the Implementation of the Electricity System Restoration Standard.”** For further information please see slides with [Panel papers](#).

## 6. Draft STC/STCP Modifications

5945. The Chair advised the Panel that no draft modifications has been submitted to July 2022 Panel.

## 7. Inflight Modification Progress

5946. TB presented on the amended legal text for **CM080 “Transmission Impact Assessment Process in relation to CMP298”**. NGESO and NGET had discussed and agreed these proposed changes to the legal text (in red) on 4.3 following the 1st Code Administrator Consultation. The wording for **4.3.2** and **4.3.3** remains unchanged.
- “**4.3** Evaluation of Transmission Impact **may require** the Transmission Owner to submit Trigger Criteria, **as agreed with NGESO** and identified in **4.3.1** to **4.3.4**, for Network Operators at GSPs within their network subject to a timetable agreed with NGESO.”
5947. The Panel discussed the changes to the legal text raised at the 1<sup>st</sup> Code Administrator Consultation. It was agreed that the change to the legal text was not typographical. Therefore, a 2<sup>nd</sup> Code Administrator Consultation should be run for just 5 working days, after which, a recommendation vote will be conducted at the August Panel.
5948. **ACTION** Panel Secretary issued **2<sup>nd</sup> Code Administrator Consultation on 08 August 2022 and it closed on 15 August 2022**. Panel vote will be sought at August Panel – voting template will be included with August Panel papers. (**Post Panel note: 2<sup>nd</sup> Code Administrator Consultation received two responses.**)
