

Headline Report - 26 October 2022

System Operator Transmission Owner Code (STC) Panel

The STC Panel Headline Report is produced after every Panel and aims to provide an overview of the key decisions made. Minutes for this meeting will be published separately.

Approval of Panel Minutes

The meeting minutes from the Panel on 28 September 2022 were approved and these will be uploaded to our website.

New Modifications

The following new Modification Proposals were presented to the Panel:

PM0126 'Transmission Impact Assessment Process in relation to CMP298 and CM080'

PM0126 seeks to facilitates an aggregated assessment that mitigates the need to assess individual smaller connections making it easier for all parties to get an accurate view of any works required.

Panel approved the STCP changes 'in principle' and agreed that it will only be implemented following a positive decision from the Authority on CMP298 and CM080. Once the Authority have decided, Panel will have to formally approve this STCP change.

PM0128 'Implementation of the Electricity System Restoration Standard in relation to GC0156'

PM0128 is seeking to make a number of changes to the System Operator Transmission Owner Code to facilitate Special Condition 2.2of National Grid's Electricity System Operator's Transmission Licence.

This modification was presented as a Draft modification to Panel and will be formally raised at the November 2022 Panel.



PM0124 'Enduring Expansion Constant & Expansion Factor Review Overview to CMP315/375'

PM0124 seeks to revise data requirements set out in the STC and facilitate changes arising from CUSC modifications CMP315 and CMP375 which amend the calculation of the Expansion Constant & Expansion factors to better reflect the growth of and investment in the National Electricity Transmission System (NETS)

This modification was presented as a Draft modification to Panel and will be formally raised at Panel once the CMP315/375 solution is sufficiently developed.

New / Pending Authority Decisions

Ofgem provided an update on Modifications that are awaiting their decision or have been decided upon since the last STC Panel on 28 September 2022.

CM084 'Clarify STCP Modification approach on Cross Code Impacts'

CM084 seeks to amend the governance rules to be more prescriptive of the interactions and timings for STC Panel to better consider STCP changes stemming from cross code modifications



The Panel unanimously agreed that CM084 has met its Terms of Reference and should proceed to Code Administrator Consultation.
