

# Headline Report – 25 January 2023

## System Operator Transmission Owner Code (STC) Panel

### Approval of Panel Minutes

The meeting minutes from the Panel on 14 December 2022 (subject to minor comments from the Panel being incorporated) were approved\* and these will be uploaded to our website.

### New Modifications

The following new Modification Proposal was presented to the Panel:

#### CM088 ‘Fault Ride Through Definition’

Seeks to make changes to Section K of the STC in order to achieve harmonisation with the Grid Code following the approval of GC0141 on the 12 December 2022, and makes amendments to Connection Conditions (CC) and European Connection Conditions (ECC) sections of Grid Code in respect of defining the requirements for Fault Ride Through

The Panel unanimously agreed that **CM088** should follow the Standard governance route and proceed to Code Administrator Consultation.

<b>CM080</b>	Process for aggregated assessment of Distributed Generators that impact (or may impact) on the National Electricity Transmission System.	28 February 2023 (previously 31 January 2023), which is at the same time as the associated CUSC Modification (CMP298).
<b>CM084</b>	Seeks to amend the governance rules to be more prescriptive of the interactions and timings for STC Panel to better consider STCP changes stemming from cross-code modifications.	31 January 2023
<b>CM085</b>	Seeks to clarify that where reactive capability is available it should be provided by OFTOs to ESO	31 March 2023
