Key areas of discussion

The aim of Workgroup 3 was to agree the Workgroup Consultation and draft legal text ahead of publishing on 20 February 2023.

Draft Legal Text

The Proposer confirmed that following the discussion at the previous Workgroup around the need for the new proposed separate clauses for managing where a CATO interfaces with Transmission Licensees, it would be simpler for industry for this information to be included throughout the existing legal text.

The Workgroup agreed with this was achieved by referring to a 'transmission area' throughout the text.

Workgroup Consultation

The Workgroup agreed that as CATO parties are yet to exist the impact of the modification should be to potential CATO parties and that there was no need for any specific Workgroup Consultation questions.

The Workgroup Consultation will be published on 20 February 2023 and closes 5pm 10 March 2023.
