## System Operator Transmission Owner Code (STC) Panel

### New Modifications

---

The following new Modification Proposals were presented to the Panel:

#### **CM089 - Implementation of the Electricity System Restoration Standard**

This Modification is proposing a number of changes to the STC to facilitate Special Condition 2.2 of NGENO Transmission Licence. Implementing an Electricity System Restoration Standard (ESRS) which requires 60% of electricity demand to be restored within 24 hours in all regions, and 100% of electricity demand to be restored within 5 days nationally.

The Panel unanimously agreed that CM089 should follow the Standard governance route and proceed to a Workgroup.

#### **PM0128 - Implementation of the Electricity System Restoration Standard**
