Key areas of discussion

The Chair opened the meeting and outlined the objectives for the Workgroup meeting which were to:

- i) Finalise the Workgroup Report
- ii) Ensure with the Workgroup that the Terms of Reference had been met
- iii) Conduct the Workgroup Vote

Actions were reviewed from Workgroup 4 to ensure they were all completed.

Workgroup Report

The Chair checked that all voting members had read the Workgroup Report and proceeded to take the Workgroup through the Report.

The Workgroup agreed to the submitted tracked changes in the Workgroup Report (including minor adjustments made on screen and the addition of extra relevant annexes).

Legal Text

No changes were made to the legal text as a result of the Workgroup Consultation and the Chair gathered agreement from the Workgroup to approve the latest version of the legal text document.

Reviewing Terms of Reference

The Chair took the Workgroup through each of the Terms of Reference and asked the group to confirm whether the term had been met and if they agreed with where said term was explained within the Workgroup Report.

Terms a), b), c), d), e), g) and h) were agreed, and for term f) the Workgroup agreed the inclusion into the Workgroup Report of a cross-code mapping table created as part of the STC/STCP mapping exercise and showing the SQSS considerations.

The Terms of Reference were unanimously approved and the Chair proceeded to the Workgroup Vote.

Workgroup Vote

The Chair explained that voting members were required to have attended for 50%+ of Workgroup meetings (themselves or via an alternate as proxy), and the five qualifying voting members confirmed their voting responses (available in the Workgroup Report) and any voting statements available.

On completion of the Vote, the Workgroup had voted by majority that the Original was to be the Workgroup recommendation for implementation.

Next Steps

The Workgroup Report was to be circulated, along with annexes, by the Chair after the meeting closed.

The Chair requested the any feedback and/or outstanding voting statements were to be sent to the box.SQSS@nationalgrideso.com by 10am on Tuesday 4 July.

The Workgroup Report will be submitted to SQSS Panel on 4 July ahead of the Panel convening on 12 July where the Report will be reviewed.

If passed to go to Code Administrator Consultation, dates are 17 July – 07 August, and SQSS Panel will reconvene on this matter at the start of September. The Final Modification Report is expected to be delivered to Ofgem on 25 September for their decision.
