Key areas of discussion

The aim of Workgroup 5 was to finalise the Workgroup Report, confirm that the Terms of Reference had been met, and to complete the Workgroup Vote.

Introductions

The Chair welcomed the Workgroup and introduced the objectives for the meeting. The Workgroup were reminded of the amalgamation of CM089 and CM091 to allow them to follow the same timeline and be sent to Ofgem for decision together. The Workgroup agreed to close all current actions.

Review of Draft Workgroup Report

The Chair presented the Draft Workgroup Report to the Workgroup for their comments. All suggested changes were implemented within the report.

- Some minor changes were made throughout the document to reflect the amalgamation of CM089 with CM091.
- A sentence was added to reflect interactions of CM089/CM091 with Grid Code modification [GC0148](#).
- For clarity, the Workgroup agreed to remove the word 'design' in Section K, where referring to OFTOs who had concluded contracts for their assets.
- Following review of the Terms of Reference, the Workgroup agreed to modify the Workgroup report to reflect that the exclusion to participating in Restoration Plans will be removed for future OFTOs. A section was added to clarify that there is no requirement for existing OFTOs and offshore generation to participate in restoration, however arrangements could be put in place for offshore generators to participate in an

offshore local joint restoration plan should they wish to do so. The proposer is awaiting guidance from Ofgem on funding arrangements for this.

Review of Terms of Reference

The Workgroup reviewed the Terms of Reference to ensure they had all been met. As above, the Workgroup report was modified when discussing ToR (f). One Workgroup member queried if there were any Terms of Reference for this modification that related to GC0148, however the Chair advised that this was not the case.

Workgroup Vote

Workgroup members assessed the Original proposal against the applicable STC objectives. The Workgroup concluded unanimously (5 out of 5) that the Original proposal better facilitates the applicable STC objectives than the Baseline.

Next Steps

The Chair thanked the Workgroup for their participation in this modification and summarised the next steps as follows:

- Workgroup Report to be shared with the Workgroup prior to being submitted to the STC Panel.
- Code Administrator Consultation due to take place from 28 July 2023 – 17 August 2023.
- Final Modification Report due to be submitted to Ofgem in September for decision.
- That implementation would be aligned with the authority decision for GC0156 rather than GC0148
