Finalise Workgroup Report and Annex 11

Workgroup Report

Workgroup reviewed the workgroup report by exception reviewing the most recent amends to it.

The workgroup agreed to move the LCP analysis section from “Workgroup Consideration for CMP315 and CMP375” to “Workgroup Alternatives”. Several workgroup members expressed the importance of Ofgem being aware on the issues the workgroup encountered with data sharing and suggested that different solutions could have been developed had this been different.

Workgroup agreed that all charts, graphs etc are to have labels, axis numbers and titles added. This also needs to be consistent with the same charts, graphs etc in Annex 11.

Following feedback PM agreed to extend and add more years to the “Smoothing in illustrated X axis is years, year 0 is prior” graph. This is to illustrate the time taken for the newly calculated expansion to approach 100% although it will never reach it.
