Key areas of discussion

The aim of Workgroup 1 was to agree the timeline and terms of reference for the modification, and to discuss the solution.

The Chair gave an overview of CMP425 explaining that the modification was raised as Urgent on the 24 October 2023 and the Authority granted Urgency on 2 November 2023. The Chair then talked through the agenda and introduced the Workgroup members. A brief explanation of the code modification process and the expectations of Workgroup members was given. The Chair presented the Timeline and Terms of Reference to the Workgroup.

Proposer presentation

The Proposer delivered a presentation on CMP425, outlining the reasons for raising the modification as urgent, what the defect and their proposed solution.

Workgroup Discussions

The Workgroup discussed the following topics, which addressed areas of consideration for the proposed solution:

- Transmission Charging Review (TCR) and CMP425 Scoping
- Connection Point versus Connection Site
- Capacity Usage versus Consumption Usage
- Codifying the Proportionality of Consumption Usage
- ESO Views
- Residual Banding and Allocation of charges
- ESO Billing System Impacts and Potential Workarounds
- Complex Sites
- Additional Stakeholder Engagement
