## New Modifications

---

There were two new Modification Proposals presented to the Panel.

### **CM094** - Amendment to Bi-annual estimate provision

*The current securities regime is unnecessarily and negatively impacting the connection of viable low carbon generation when network infrastructure already has regulatory approval.*

Panel members agreed by majority that the Modification should proceed under the urgency governance process. A letter has been issued to the Authority requesting urgency approval. A decision is due by Monday 5 February 2024.

### **PM0137** - Queue Management Coordination Procedure

*A new procedure to ensure effective coordination and collaboration between STC Parties in respect of the ESO's administration of Queue Management changes applied in CUSC via recently approved modification [CMP376](#).*

The majority of Panel members confirmed their approval for the Proposal to be implemented (along with Ofgem). Further review of legal text to take place by a Panel member and a decision regarding approval is to be confirmed by Friday 2 February 2024. The Proposal will be presented again to the next STC Panel if approval is not received.

<b>CM089/CM091 Emergency and Restoration Code Phase II</b>	Clarify the requirements on STC parties in order to implement the requirements of the EU Emergency and Restoration Code.	Relates to GC0156/GC0148, expected decision moved to 05 February 2024
<b>CM079 Consideration of STC/STCP changes in relation to CMP330/374</b>	This modification will consider the proposals being discussed in CMP330/374 and how these might lead to STC or STC Procedures to ensure any consequential changes are proportionate	Relates to CM330/374, expected decision date 08 May 2024.
