## Key areas of discussion

The aim of Workgroup 1 was to agree the timeline and terms of reference for the modification, and to discuss the solution.

The Chair then talked through the agenda and introduced the Workgroup members. A brief explanation of the code modification process and the expectations of Workgroup members was given. The Chair presented the Timeline and Terms of Reference to the Workgroup.

### Timeline

The Workgroup reviewed the timeline for CM093 and questioned if the Workgroups for CM093 and CUSC Modification CMP417 could be more aligned and suggested the Workgroups be held on the same day. The Chair agreed to review the timeline and see if any amendments could be made to further align the Workgroups.

### Terms of Reference

The Workgroup reviewed and agreed the Terms of Reference (ToR) for CM093. A Workgroup member had a further point of clarity on Term of Reference d '*The cross code impacts this modification has, in particular on the CUSC*' noting that the CMP417 has an impact on the STC, which is why CM093 is a consequential modification and going forward both CUSC and STC Workgroups need to ensure co-ordination with each other.

### Proposer presentation and questions

The Proposer delivered a presentation on CM093 outlining the reasons for raising the modification. The Workgroup felt that further work on defining the solution for CM093 was needed from the Proposer for the Workgroup to form further discussions.

### Cross Code Impacts

The Workgroup discussed and acknowledged the ongoing CUSC Workgroup CMP417: Extending principles of CUSC Section 15 to all Users.
