Key areas of discussion

The Chair welcomed the attendees and confirmed quoracy, noting that GC0159 has been sent back to Workgroup by the Panel in order to consider interactions with GC0156, specifically regarding the legal text.

Review Legal Text

The Proposer presented the GC0159 legal text alongside the GC0156 changes to the Workgroup, highlighting where there were legal text interactions.

Glossary and Definitions

- One Workgroup member requested a clarification in the definition of Local Safety Instructions.
- One Workgroup member queried whether any of the GC0156 definitions change any of the CATO definitions being introduced. The ESO representative advised that they were not aware of any changes required.
- The ESO representative noted that they had reviewed the Transmission System definition alongside the SQSS CATO modification to ensure consistency.
- The legal text was agreed by the Workgroup subject to other minor changes.

Balancing Code 2

- The Workgroup had no comments on the revised legal text.

Operating Code 9

- The Workgroup discussed and agreed the legal text.

Planning Code

- The Workgroup discussed whether CATOs should be exempt from PC.C.1. This was agreed by the Workgroup, however it was noted that it may need to be addressed within a future modification.

- Appendix C Part 3 – The Workgroup agreed that this must align with the STC modifications and queried whether there was alignment. It was also noted that part 3 only applies to England and Wales. Some Workgroup members stated that they believed this section was out of scope for the modification, and the Workgroup therefore removed this proposed section and agreed it should be addressed in a subsequent modification.

General Conditions

- GC.11.5 – The Workgroup agreed to remove this proposed text, believing it to be out of scope of the modification.

Workgroup Report

The Workgroup discussed and agreed additional text to go in the Workgroup Report.

Workgroup Vote

The Workgroup confirmed their votes had not changed as a result of the legal text amends.
