What is the issue?

Some sections of the STC currently reference “fax” and “facsimile” as communication methods between TOs and the ESO, but the use of fax machines has been superseded over time to with other methods of communication such as email.

Why change?

The STC is currently out of date as references to Fax and Facsimile are no longer applicable.

What is the proposer’s solution?

Update the relevant sections of the STC to remove references to fax and facsimile and replace with appropriate wording to reflect how communications between the TOs and ESO currently take place.
