**Rationale:** Connection Reform continues to be unprecedented in scale and ambition, reflecting the importance of the challenges which the industry are seeking to resolve collectively.

Previously the timeline was based on a sequential plan with decisions on Code Modifications in December 2024 and decisions on Methodologies in February 2025, the new timeline is based on Ofgem coupling the decisions on Code Modifications and Methodologies in Q1 2025.

The reforms are complex, and it's important that when the final modification report is submitted to the Authority for their decision that solutions have had robust review.
