- 12557. Apologies were received from Catia Gomes, Paul Jones, Joe Colebrook and Rashmi Radhakrishnan.
- 12558. Declarations of interest were made by AP regarding CMP414 and GG regarding an interaction of GC0117 with CMP439.

12559. The Chair advised Panel members that the meeting minutes from the CUSC Panel held on the 12 and 26 July 2024 would be presented at the September CUSC Panel meeting.

#### **Authority Energy Code Reform Update**

12564. NH advised Panel members that the Energy Code Reform decision was issued on 22 August 2024 to industry and shared the <u>link</u> to the relevant webpage. NH also advised that the next opportunity to contribute to the development of the Strategic Direction Statement will be in the winter consultation. The Chair noted that this would be an appropriate milestone for the Panel to receive another update from the Ofgem team.

12563. A question was raised regarding expected decision date for GC0117. NH responded advising there would be a minded to consultation in September, all recommendations would then be considered, and a "minded to" decision made by the Authority in December 2024.

#### 7. New Modifications

# CMP439: Removal of Bilateral Embedded Generator Agreement (BEGA) obligation for a sub 100MW Generator

- 12564. NS presented CMP439 to the Panel, which looks to remove the requirement for ≥100 MW licenced embedded generators to have a BEGA before participating in the Balancing Mechanism.
- 12565. It was highlighted that this modification had interactions with GC0117. DA wanted to understand what the interactions were with GC0117, and if changes would be required to the definition. GG advised there would be no new obligations, the modification was simply harmonising across GB. DA questioned if BEGA was being replaced with something else, what would that look like, adding that further analysis might be useful before a decision is made to progress with this modification.
- 12566. The Chair suggested it would be useful to understand the proposed Governance route for CMP439. CG confirmed the Proposer is requesting that the modification follows the Standard Governance route proceeding straight to Code Administrator Consultation if approved at Panel.
- 12567. DA raised a concern that no analysis had been performed by the Proposer. DA felt further work was required to fully understand the issue prior going to Code Administrator Consultation and analysis would be needed to appreciate the depth of the problem.
- 12568. Panel members agreed that further work was required and advised the Proposer to reconsider the Proposal and assess the impact before bringing it back to Panel next month.

## 8. In flight modification updates

CMP414: CMP330/CMP374 Consequential Modification

- 12569. CG presented the updated timeline.
- 12570. Panel approved the new timeline and agreed that the prioritisation would be discussed later in the meeting.

#### **Connections Update**

- 12571. A representative from the Connections team and an Ofgem Representative joined the CUSC Panel meeting to give an update on the Urgent Connection Modifications currently in progress.
- 12564. RJ advised Panel members the decision on the connection modifications would not be made in December 2024 and would be moved out to Quarter (1) 2025. The ESO and Ofgem confirmed that the timeline had been built on the basis of Ofgem coupling the decisions on Code Modifications and Methodologies in Q1 2025.

# **ESO**

- 12565. Therefore, the methodologies, licence changes, and code modification will be consulted and Ofgem will decide on all regulatory changes together having consulted on the complete package of reforms and published an impact assessment.
- 12566. A detailed timeline was currently put together that would be presented at a Special Panel once completed.
- 12567. LW added that a letter would be issued by the Authority to give clarity on the details and to help industry understand how things would work going forward.
- 12568. GG advised that, as currently the methodologies do not yet exist, it might be an idea to engage with industry stakeholders who could offer support and assist in putting the methodologies in place.
- 12569. RJ advised that at present there was not a fully formed process in place but would take into consideration the Panel member's suggestion.
- 12570. LW added that members could send any suggestions to the Authority to be considered.
- 12571. HH wanted to understand from the Panel what the bottlenecks were making it necessary for a further hiatus, and if it was an issue across industry or localised to certain companies.
- 12572. GG advised that within their organisation they had several resources to cover different modifications but other companies within the industry may not.
- 12573. Several members gave examples of where there was a shortage of resource, not just within this sector. This had caused issues with quoracy for meetings/forums leading to cancelations.
- 12574. After careful consideration, the Panel agreed to the continuation of the current workgroup meeting hiatus.

#### 8. Workgroup Reports

12575. No Workgroup Reports were presented to the August CUSC Panel.

## 9. Draft Final Modification Reports (DFMR)

# CMP430 Adjustment to TNUoS charging from 2025 to support the Market Wide Half Hourly Settlement (MHHS) Programme

- 12576. CG presented the Draft Final Modification Report to the CUSC Panel.
- 12577. The Panel held their Recommendation Vote for CMP430 and agreed unanimously that the Original Proposal better facilitates the CUSC Objectives than the Baseline. The Final Modification Report will be issued to the Authority on 23 August 2024.

#### CMP438: Clarification of Illustrative Example of a TNUoS Demand Reconciliation

- 12578. GC presented the Draft Final Modification Report to the CUSC Panel.
- 12579. The Panel held their Determination Vote for CMP438 and agreed unanimously that the Original Proposal better facilitates the CUSC Objectives than the Baseline.
- 12580. The Final Self Governance Modification Report will be shared with Panel members on 27 August to check voting has been captured correctly. It will then be issued to industry for a 15 Business Day Appeals window which will close on 25 September 2024. If no objections are raised the Proposal will be implemented on 2 October 2024.

#### 10. Discussion on Prioritisation

#### The updated Prioritisation Stack can be found here.

- 12581. The Panel reviewed the prioritisation stack.
- 12582. AP expressed concerns regarding the new proposed timeline for CMP414 presented to Panel earlier in the meeting. AP explained how the modification had already taken four years and the new timeline would mean process completion in a total of seven years. AP felt the modification is not only a part of Connections Reform, but it has also benefitted in moving to net zero and should therefore be placed in a higher position in the prioritisation stack.
- 12583. DA sympathised but confirmed that the duration of a modification is not one of the prioritisation criteria and that the rationale behind moving CMP414 should be based on the complexity, importance and urgency of the modification.

# **ESO**

- 12584. Panel members discussed how CMP414 is aiming to speed up the connections process and therefore could be considered important. The majority of Panel members agreed that CMP414 should be reprioritised as Medium/High.
- 12585. ML clarified to manage Panel expectations that reprioritisation will have no impact on the proposed timeline as the current hiatus is continuing.

12586. DA confirmed that, as there were no agenda items for the August meeting, it will be cancelled, the next meeting will be 5 September 2024.
