Grid Code Review Panel

Approval of Panel Minutes

The meeting minutes from the Panel on 26 September 2024 were approved subject to minor comments from the Panel being incorporated and these have been uploaded to our website here.

New Modifications

The following new Modification Proposal was presented to the Panel:

GC0175: Removing references to "Fax" or "Facsimile" within the Grid Code | National Energy System Operator

The modification seeks to remove references to "fax" and "facsimile" from the Grid Code to reflect both current and future methods of communication between relevant Users and the National Energy System Operator (NESO) due to the national decommissioning of the Public Switched Telephone Network (PSTN).

The Panel unanimously agreed that GC0175 should follow the Standard Governance route and proceed to Code Administrator Consultation. The Panel agreed the Terms of Reference for the Workgroup.
