Key areas of discussion

The Chair confirmed the aim of Workgroup meeting I was to discuss the modification process, Workgroup responsibilities, agree timeline, agree Terms of Reference, and review the proposed solution.

Code Modification Process Overview

The Chair outlined the Code Modification Process and defined the role and expectations of a Workgroup Member. Also confirming that this was a Limited Membership Workgroup.

Proposer Presentation

The Proposer summarised that GC0174 has been raised following the approval of BSC Modification CP1583 (Rationalising publication of European Transparency Regulation data on Elexon Systems), the obligation for parties to submit EU Transparency Availability Data as specified in OC2.4.7 is no longer required.

The Proposer also sought a legal view on the proposed changes and provided the Workgroup with a summary of this. It was highlighted by Workgroup members that whilst having this legal view was helpful for the Workgroup discussions, a proper legal assessment would be required for further clarity on aspects of the solution. Workgroup member also requested a legal view on the following:

How ETR data is considered to be different to the REMIT data under EU legislation, acknowledging the implementation of (P291: REMIT inside information reporting platform and GB Electricity, P295: Submission and publication of transparency regulation data via the BMRS and GC0083: European transparency regulation implementation), and questioned if compliancy would still be met under the proposed solution for GC0174.
