## Workgroup Reports

The following Workgroup Report was presented to the Panel:

### GC0164: Simplification of Operating Code No.2

This modification seeks to help Users to clearly identify and understand their obligations under Operating Code No.2 (OC2) by making it more accessible, easy to navigate and understand. This is the first modification resulting from the Alignment, Simplification and Rationalisation Workstream (ASRW) of the Digitalised Whole System Technical Code project.

The Panel agreed that the Terms of Reference have been met and agreed for GC0164 to proceed to Code Administrator Consultation. The Code Administrator Consultation will be published on 02 December, and this will close on 16 January 2024.

## Draft Final Modification Reports

The following Draft Final Modification Report was presented to the Panel:

### GC0159: Introducing Competitively Appointed Transmission Owners

This modification aims to introduce the concept of Competitively Appointed Transmission Owners (CATOs) to the Grid Code to enable Onshore Network Competition for the design, build and ownership of Onshore Transmission assets.

The Panel concluded that in order to complete the Panel Recommendation Vote, further work was required to the DFMR.
