



CUSC Headline Report November 2024

Approval of Panel Minutes

The meeting minutes from the Panel on 25 October 2024 and the Special CUSC Panel on 08 November 2024 will be approved at the Panel on 13 December 2024.

New Modifications

The following new Modification Proposal was presented to the Panel:

<u>CMP445 Pro – rating first year TNUoS for Generators</u>

This modification seeks to amend the CUSC to ensure that Generators only pay TNUoS on a pro-rated basis from their Charging Date, during the first year of connection.

The Panel majority agreed that CMP445 met the Authority's Urgency criteria (a), and therefore recommended urgent treatment. Panel's recommendation was sent on 29 November seeking an Authority decision by 5pm on 05 December.

The Panel recommended that CMP445 proceed to a Workgroup. The Panel agreed to discuss and agree the Workgroup terms of reference offline.
