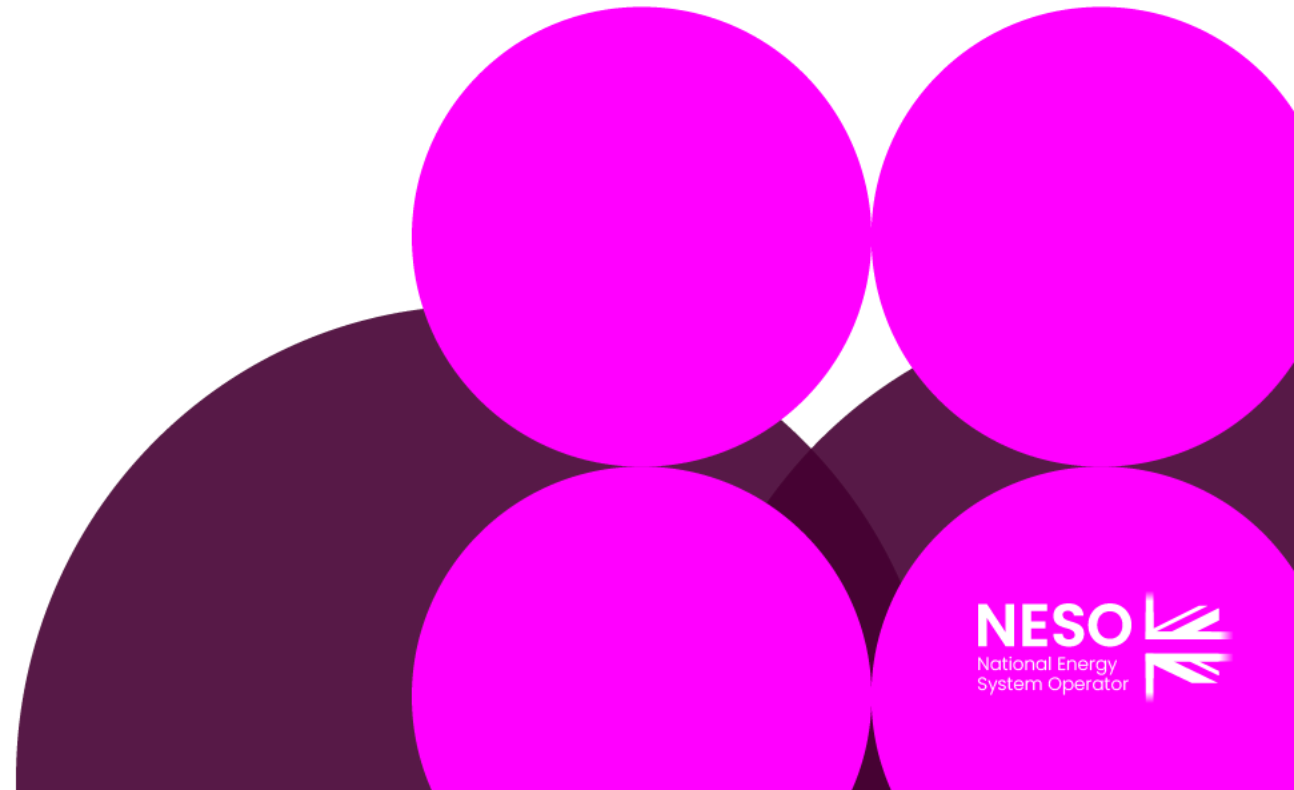

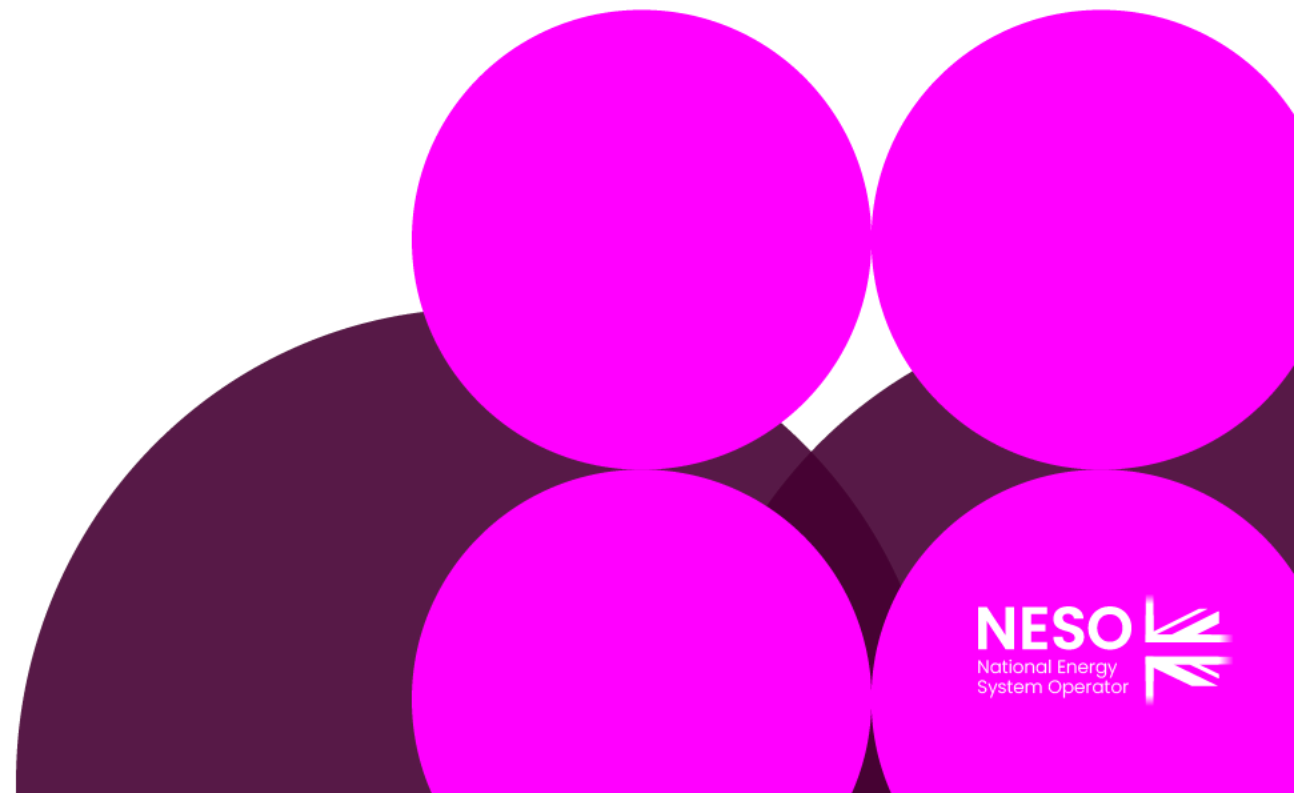

Current Status

- CMP434 Code Administrator Consultation has closed
- CMP435 Code Administrator Consultation has closed
- CM095 Code Administrator Consultation has closed
- CM096 was withdrawn on 28 October 2024 on the proviso that Transitional Arrangements are to be contained in a new STCP
- PM0142 and PM0143 were raised in November 2024 and STCP changes are being drawn up with the aim to be ready for January 2025 STC Panel
- The purpose of this presentation is to cover the changes to the STC Procedures and demonstrate that they are material changes

Materiality of STCP Changes (PM0142)

- NESO will be writing to Ofgem advising of these STCPs are believed to be material as part of this modification

STCP Governance

If a change is developed which has the potential to materially amend an existing STCP the proposer is obligated to seek Panel's views on materiality before proceeding.

When considering the proposed changes to the STCPs, the first ask on voting members is whether you agree that the change is material.

- If not, then approved/rejected as has been done in the past;
- If material, then the proposer of the change would need to seek Ofgem's written approval to proceed, and to clarify who should approve the change.

Ofgem can then decide either:

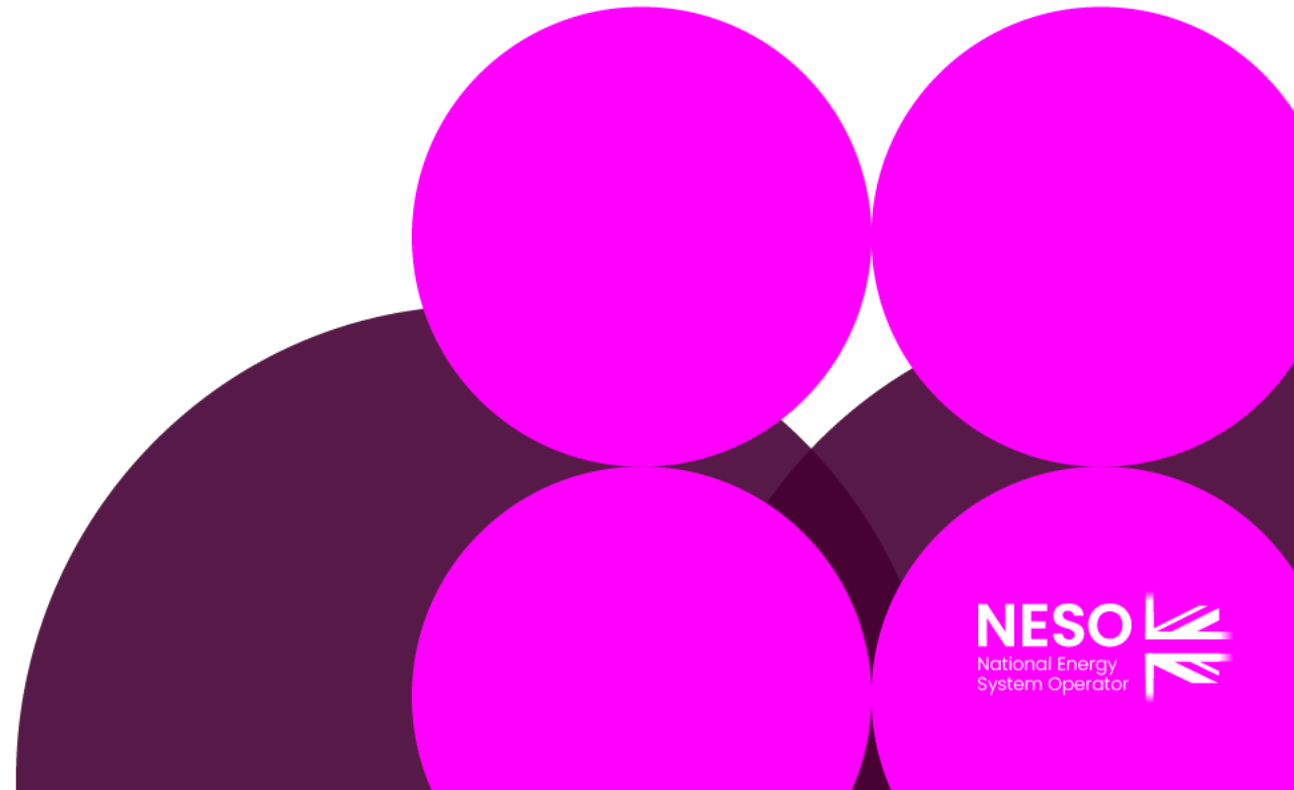
- It is acceptable for the Panel to approve/reject the STCP changes (as has been done in the past; or
- They will make the decision themselves.

PM0133 – the asks of Panel

- **AGREE** to the proposed name change of the modification from 'Pathfinders Feasibility Studies' to 'Network Services Feasibility Studies' in line with the legal text
- **AGREE** that the materiality of the STCP change
- **AGREE** the implementation next steps
- **NOTE** that Implementation Date will be **10 January 2025** if Panel agree to implement this change and Panel identify no material impacts

Affected Transmission Owner Construction Offers (TOCO) (1)

NESO Contract Managers manage the process of making TO Construction Offers in response to receiving a connection application.

The process is described in STCP 18-1, which sets out the requirements on all TOs, including onshore TOs and OFTOs.

NESO Contract Managers have identified some implementation issues with the process where the affected TO is an OFTO, including:

- Whether the application fees are sufficiently cost reflective where OFTOs are identified as an affected TO in the process;
- Whether all of the timescales in the process are feasible (including OFTOs timescales for declaring technical competency);
- Whether more clarity is needed within the STCPs on information sharing between all parties (host TO and affected TO);
- Whether all parties are aware of -their obligations in the process; and
- Obtaining signature of OFTO ATOCOs and differences in financial governance arrangements between onshore TOs and OFTOs.

Affected Transmission Owner Construction Offers (TOCO) (2)

We believe the issues identified need to be addressed due to the increase in affected OFTOs in assessing connection applications, and the expected introduction of CATOs in the future (i.e. the problem will only grow).

We are mindful of potential interactions with the Connection Reform Mods (namely CM095) and will monitor those developments.

Ask of Panel – for awareness: Prior to developing proposals for STCP changes to address the above, we would like to hold discussions with relevant parties (starting with OFTOs), with a view of sharing our observations and obtaining feedback.
