# **Request for Information**

Thank you for your request for information which was received by the Information Rights team on 12 December 2024.

You submitted your request under the Freedom of Information Act 2000. The exemption at Section 39 of the Freedom of Information Act 2000 (FOIA) covers information that a public body is obliged to consider under the Environmental Information Regulations 2004 (EIR) and has the effect of routing all requests for environmental information via the EIR rather than the FOIA.

Your request has therefore been considered under the EIR as we believe that the requested information falls within the definition of environmental information as provided by Regulation 2(1)(c).

#### Request

In your email dated 12 December 2024 you stated:

On Page 3 of your Beyond 2030 Technical Report you state

"In developing the Beyond 2030 report, we have collaborated closely with Transmission Owners (TOs) and engaged with a range of interested parties including government department, the regulator (Ofgem), wind farm developers and environmental and community representatives".

Accordingly, under the Freedom of Information Act 2000 I would wish to be provided with the names and dates of the meetings of the meetings you have had with environmental and community representatives and the organisations they represent as you undertook to do."





### **Our response**

We can confirm that we hold information which falls within the scope of your request. Information on stakeholder engagement can be found in the Stakeholder Approach, Engagement and Feedback Report, published on NESO's Beyond 2030 website: <a href="Measurements-Beyond 2030">Beyond 2030</a> | National Energy System Operator.

Information about the Central Design Group (CDG) and the Environmental Subgroup (ESG) is available on pages 12 and 13 of the Stakeholder Approach, Engagement and Feedback Report.

The meetings with the Central Design Group (CDG) and Environmental Subgroup (ESG) in the table provided below were held during the Holistic Network Design Follow Up Exercise (HNDFUE) and Transitional Centralised Strategic Network Plan (tCSNP2) process as part of the development of the Beyond 2030 Report.

For information, prior to publication of the Beyond 2030 Report, NESO also undertook engagement with politicians, including with Ministers, MPs, MSPs, MSs, on behalf of the regions and communities they represent. This engagement was not related to the development of the content of the Beyond 2030 Report.

CDG was attended by a Community Representative who attended on behalf of the Local Government Association (LGA) Coastal Special Interest Group (SIG), representing 57 local authorities who are members of the LGA Coastal SIG.

The ESG, a subgroup of the CDG, brought together environmental stakeholders to provide advice on environmental impacts of technically viable options being considered when developing the HNDFUE. Membership of the ESG was:
