Discussion and details

1. **CM095 Send Back Update**

The Chair shared with the Workgroup that on 20 January 2025, Ofgem sent back the CM095 Final Modification Report for further work and directed the STC Panel to revise and resubmit the Final Modification Report by 29 January.

The Chair shared details of the send back explaining the modification had been sent back due to changes made to the applicable code objectives during the modification process, which the modification was not assessed against. The Chair detailed that the Authority has requested that a further Workgroup Vote, Code Administrator Consultation and STC Panel Vote are undertaken in respect of the amended/additional objectives.

2. **CM095 Second Workgroup Vote**

The Chair led the second Workgroup vote asking Workgroup members to vote against the amended/additional STC applicable objectives.

b) efficient discharge of the obligations imposed upon the licensee by the Electricity System Operator licence, the Energy Act 2023 and Electricity Act 1989;

e) protection of the security and quality of supply and safe operation of the National Electricity Transmission System insofar as it relates to interactions between Transmission Licensees and the licensee*;

The Workgroup concluded by majority that the Original and ASM1 better facilitated the Applicable Objectives than the Baseline.

3. **Next Steps**

- Second Code Administrator Consultation to be published on 22 January 2025 and close on 24 January 2025.
- Draft Final Modification Report to be submitted to the STC Panel on 27 January 2025.
- STC Panel Vote and Second Final Modification Report to be submitted to Ofgem on 29 January 2025.
