### Key areas of discussion

- **Implementation Timeline:** The workgroup discussed the need for a clear implementation timeline, with several workgroup members emphasizing the importance of specifying a definite timeframe to ensure all affected parties are prepared. It was also suggested that a backstop date be included to ensure timely implementation. **Action 32**
- **Process Concerns:** The workgroup discussed process concerns, including the need for relevant personnel to sign off on the solution. **Action 33**
- **BMUs and Energy Source:** The workgroup discussed multiple scenarios involving BMUs, energy sources and hybrid units. The NESO SME explained the need to model each component individually to ensure the proposal works effectively. **Action 34**
- **Technical vs. Commercial Parameters:** The workgroup discussed the distinction between technical and commercial parameters, with concerns raised about the potential for unintended consequences. It was agreed that further consultation with market monitoring and compliance teams was needed. **Actions 35, 36, 37,38 and 39**
- **Legal Text Clarifications:** The workgroup discussed the need for clear definitions and defaulting rules in the legal text, suggesting the use of "energy constrained" instead of "limited" or "unlimited" storage to provide better clarity. **Actions 40 and 41**
