Approval of Panel Minutes

The meeting minutes from the STC Panel on <u>11 December 2024</u> and <u>Special Panel on 20 December 2024</u> were approved and these have been uploaded to the relevant webpages.

New Modifications

The following new Modification Proposals were presented to the Panel:

PM0141 Incorporating a revised outage change code list in STCP11-2 Appendix 5

The current list of Outage Change Codes contained within STCP 11-2 Appendix 5 is in need of review to remove duplicates, to remove ambiguity and include new codes to better reflect the reasons for outage change

The Panel unanimously agreed that PM0141 can be implemented once the Proposer has agreed the implementation date. This will be shared with Panel members once agreed.

PM0144 Digital Communication System Integration

This modification seeks to remove references to "fax", "facsimile", and "email" from the STCPs in order to reflect both current and future methods of communication between relevant Users and the National Energy System Operator (NESO) due to the national decommissioning of the Public Switched Telephone Network (PSTN).

The Panel unanimously agreed that PM0144 should be implemented on the date suggested.

The following Second Draft Final Modification Report was presented to the Panel:

CM095 Implementing Connections Reform

The current connections process is not enabling the timely connection of projects to meet net zero. A wholesale revision is needed to the connections process to meet those targets and the needs of project developers and consumers. This proposal introduces new processes and definitions that will update the existing processes and enable projects that are most ready to progress more rapidly to connection.

The Panel recommended unanimously that the Proposer's solution better facilitate the STC Applicable Objectives. The Second Final Modification Report will be issued to the Authority on 29 January 2025.
