Key areas of discussion

Meeting Objectives

The Chair outlined details of the meeting agenda, which included action updates, legal text review, Workgroup Consultation discussion, Terms of Reference review, timeline, AOB, and next steps.

Open Actions

The Proposer confirmed the outstanding action had been addressed and these would be discussed when reviewing the legal text.

Legal Text Review

Workgroup members comments were reviewed and necessary updates made by the Proposer.

Comments in section PCA.5.4, were discussed and most were closed. As the Proposer wanted to give some further thought to a few comments, these remain open.

In section PCA.9.2.2 Workgroup discussed the legal text updates; the Proposer was satisfied there was a good representation of the requirements for electromagnetic transient models and data from users.

The Proposer addressed comments on time frames for submissions, emphasising the importance of quality and accuracy in the models, as specified in PCA 9.

There was a request for extra clarification in relation to the references in PCA9.7 regarding plant and apparatus, the Proposer talked this through with Workgroup members adding further clarification.

Workgroup Consultation Discussion

The Chair went through the comments on the consultation document, addressing various suggestions and making amendments as needed. The importance of a cost recovery mechanism was discussed and the need for clear guidelines. Workgroup members proposed to include a question in the workgroup consultation seeking their input from Industry on their proposed solutions regarding cost recovery.
