1. Introductions, Apologies and Declarations of Interest



10687. Apologies were received from Matthew White and Darshak Shar 10688. The chair welcomed Kat Higham from NESO Code Governance and

the new 2025 Panel members, who were all observing.

10689. No declarations of interest were received.

2. Minutes from previous meeting

10690. Due to the proximity of the last two meetings, the meeting minutes from

the Grid Code Review Panel held on 28 November and 12 December will

be approved in January.

3. Review of actions log

10691. The Grid Code Review Panel reviewed the open actions from the

meeting held on 28 November 2024, which can be found on the Actions

Log.

10692. The Panel agreed that Actions 456 and 465 should remain open.

4. Chair's update

10693. The Chair advised that there were no updates this month.

5. Authority Decisions

10694. GS advised the Panel that the consultation on GC0117 would be

published on 14 January 2025, with the decision date expected on 25

March 2025.

10695. The expected decision date for GC0172 was advised as 12 February

2025.

10696. GS provided an Energy Code Reform update which advised that the

Authority has published its consultation on code manager selection, which is being proposed as a three-stage process for both competitive and non-competitive selection. The consultation is available on the

Ofgem website and will close on 30 January 2025.

6. New modifications

<u>GC0176 - Introduction of Demand Control Rotation Protocol within Operating Code 6</u> <u>of the Grid Code</u>

10697. RS delivered a presentation on GC0176, which aims to make changes

to OC6 to allow for the Demand Control Rotation Protocol (DCRP) to be formally recognised as a tool to manage shortfalls in electricity

supply over an extended period of time (i.e. 3 to 24 hours).

10698. RS advised that, for national security reasons, NESO will be unable to

publish the complete version of DCRP into the public domain.

10699. FK recommended a joint workgroup with the Distribution Code Review

Panel and that, although no specific conversations had taken place, the

Distribution Code Review Panel were aware of the Proposal. The

Panel agreed with this Proposal.



10700. The Panel agreed unanimously that GC0176 should follow the Standard Governance Route and proceed to Workgroup.

10701. The Panel agreed Terms of Reference for the Workgroup, with SW

to circulate the collated list to Panel members for review.

10702. SC presented the timeline, with a Panel member raising that the

proposed first Workgroup on 29 January 2025 would be before the next Distribution Code Review Panel meeting, suggested that it might

be possible for the Terms of Reference to be agreed by email.

7. In flight modification updates GC0164: Simplification of Operating Code No.2

10703. SW provided an update on GC0164 to confirm that, due to the Christmas period the Code Administrator Consultation had been extended by two weeks. This had been recommended by Panel

members at the last meeting.

8. Workgroup Reports

10704. There were no updates for the Panel

9. Draft Final Modification Reports <u>GC0159: Introducing Competitively Appointed Transmission Owners</u>

10705. SC presented the third Draft Final Modification Report for GC0159 to the Panel, noting that 8 Code Administrator Consultation responses had been received.

The Panel reviewed the proposed legal text amendments and agreed that they were typographical and could be made.

10707. The Panel held their Recommendation Vote for GC0159 and agreed, by majority, that the Original Proposal better facilitates the Grid Code Objectives than the Baseline. The Final Modification Report will be issued to the Authority on 31 December 2024.

10. Discussion on Prioritisation

10708. The Panel reviewed the prioritisation stack. The updated Prioritisation Stack can be found via the following link: Grid Code Prioritisation Stack - December 2024.xlsx

10709. It was agreed, by majority, that <u>GC0176 - Introduction of Demand</u>
<u>Control Rotation Protocol within Operating Code 6 of the Grid</u>
Code should be added at position number 4 in the prioritisation stack.

CN advised Panel that the GCDF was held on 04 December 2024 and covered modelling requirements for co-located sites, extension of user model submission for analysis and modelling to support the operationally critical system for the ENCC, as well as the Obligatory Reactive Power Service (ORPS) methodology review. closed on 06 December 2024. No appeals were received.
