Approval of Panel Minutes

New Modifications

The following new Modification Proposal was presented to the Panel:

CMP447 'Follow on Modification to CMP428'

This modification seeks to adjusts the fixed attributable works of relevant generators where CMP447 would have benefited them had they not fixed, by removing the relevant element of their fix, the rest of the fix remaining as an intact fix. The principle otherwise remains undisturbed that fixing of attributable works is permanent and irreversible.

The Panel unanimously agreed that CMP447 should follow the Standard Governance route and proceed to a Workgroup. The Panel agreed the Terms of Reference for the Workgroup.

Draft Final Modification Reports

The following Draft Final Modification Report was presented to the Panel:

CMP443 'Removing references to "Fax" or "Facsimile" within the CUSC

This modification seeks to remove references to "fax" and "facsimile" from the CUSC in order to reflect both current and future methods of communication between relevant Users and the National Energy System Operator (NESO) due to the national decommissioning of the Public Switched Telephone Network (PSTN).

The Panel has recommended unanimously that the Proposer's solution better facilitate the CUSC Applicable Objectives. The Final Modification Report will be sent to Ofgem on 11 February 2025.
