## Approval of Panel Minutes

## New Modifications

The following new Modification Proposals were presented to the Panel:

### **CMP449: Rectifications to pending 01 April 2025 implementation legal text**

This proposal aims to correct legal text errors in modifications which have been approved by the Authority ([CMP411](#), [CMP424](#) and [CMP430](#)) which are due to be implemented on 01 April 2025.

The Panel unanimously agreed that CMP499 should follow the Fast Track Self Governance route and for the Appeals Window to take place from 03 March to 5pm on 24 March 2025. The modification will be implemented on 01 April 2025 if no Appeals are received.

### **CMP450: Introducing the definition of Dynamic Reactive Compensation Equipment (DRCE) in the CUSC**

This modification seeks to introduce the definition of Dynamic Reactive Compensation Equipment (DRCE) in CUSC Section 11, aligning the definition to that included in the Grid Code.

The Panel unanimously agreed that CMP450 should be Standard Governance route and proceed to Code Administrator Consultation.

## Draft Final Modification Reports

The following Draft Final Modification Report was present:

### **CMP418: Refine the allocation of Dynamic Reactive Compensation Equipment (DRCE) costs at OFTO transfer**

CMP418 seeks to address the commercial imbalance between offshore and onshore generators by removing dynamic reactive compensation equipment (DRCE) costs from the Offshore Generator's TNUoS tariff.

The Panel has recommended by majority that the Proposer's solution better facilitates the CUSC Applicable Objectives. The Final Modification Report will be sent to Ofgem on 11 March 2025.
