### Key areas of discussion

The meeting focused on discussing the consultation document, the impact of the change and the need to review highlighted or deleted parts.

#### **Workgroup Consultation Document Review**

The Chair highlighted the need to review specific sections of the document that were either highlighted or deleted. The group agreed to focus on these areas to ensure all outstanding questions and comments were addressed before finalising the document.

The Proposer and a Workgroup member discussed the adjustment credit and its impact on demand residual charges. They agreed to include a statement about the impact on demand residual charges in the executive summary.

The Chair and the Workgroup members worked on finalising the wording for the Executive Summary, ensuring it accurately reflected the impact of the change on generators and demand charges.

The Workgroup agreed that it would be helpful to carry out additional tariff impact analysis, including the impact on later charging years and a breakdown by different types of generation technology.

The Proposer and Workgroup members discussed the structure of the Workgroup report, debating whether to include arguments for and against the modification in separate sections or within the same section and it was agreed for the 2 differing perspectives to be separated, with a comment advising readers of this.
