








Purpose of Panel & Duties of Panel Members


- 4.2 Functions of the Panel
 - 4.2.1 The Panel shall consider all reasonable requests to modify the SQSS. Such requests may be made by any of the Members, the Authority or any relevant interested person. SQSS Modification Proposals shall be raised via the Secretary.
 - 4.2.2 The functions of the **Panel** shall be to:
 - 4.2.2.1 keep the **SQSS** and its working under review;
 - 4.2.2.2 evaluate and administrate modifications to the SQSS in accordance with procedures set out in the Governance Framework;
 - 4.2.2.3 keep the **Governance Framework** and its working under review;
 - 4.2.2.4 publish recommendations to modify the SQSS and the reasons for the recommendations;
 - 4.2.2.5 recommend to the Authority any modifications of the SQSS; and
 - 4.2.2.6 the **Panel** shall endeavour at all times to perform its functions:
 - in an efficient, economical and expeditious manner, taking account of the complexity, importance and urgency of a particular modification to the SQSS; and
 - (b) with a view to ensuring the SQSS facilitates achievement of its objectives.

GSR033: Code Maintenance

Solution/summary of solutions:

- With the changes to the licence modification coming into effect on 07 February 2025, this
 modification aims to enable NESO to fulfil its obligations under the new licence
 arrangements. The key change here is the incorporation of the Governance Framework
 into the SQSS.
- A further update will be made to the SQSS to correct an error identified with the legal text implemented when Establishing ISOP in industry codes on 01 October 2024.
- Following consultation legal text changes have been made accordingly within the scope of the modification.
- It is noted that there are several formatting and typographical issues with the within the SQSS. There will be addressed in a future housekeeping modification.



Code Administrator Consultation Responses

Summary of Code Administrator Consultation Responses:

Code Administrator Consultation was run from 30/02/2025 to 20/02/2025 and received 2 non-confidential responses. Key points were:

- One respondent agreed with the implementation approach and one did not, noting that they
 support the transition of the NETS SQSS to a more open and transparent governance
 framework but highlighted several areas that need clarification.
- GSR033 should ideally only introduce changes associated with implementing the directed governance framework, but it seems several issues with the baseline text and pre-existing issues have been identified, including the new definition of 'Licensee'.
- It was the preference of one respondent that all issues within the SQSS text should be resolved as part of this modification.
- No additional legal text issues identified with text relating to GSR033

- **VOTE** whether or not to recommend implementation.
- NOTE next steps
 - Due to the tight timeline this will proceed to Ofgem for decision ahead of implementation on 31 March 2025
