GC0169 Actions and Legal Text

Actions

The Proposer confirmed that Actions 9 and 10 have been closed following discussions with NESO Legal. The General Conditions have been updated and shared with the Workgroup.

The Proposer discussed the updated Legal Text which had been shared with the Workgroup, noting that previously discussed items and new changes have been highlighted for clarity. The Proposer agreed to include this table in an Annex to the Consultation Document.

Public GC0169 Draft Workgroup Consultation Report

A Workgroup Member raised a concern that this solution may have an interaction with G99. The Proposer took an action to continue these discussions and share an updated solution with the Workgroup, including those specific Workgroup Members who have an interest in G99.

The Chair confirmed that the GC0173 Legal Text will be shared along with the GC0169 Legal Text, with final comments to be submitted by Friday 21 February 2025.

GC0173 Draft Workgroup Consultation Report
