## Role of a Panel Member

---

- An opportunity to act as an independent industry expert in setting the strategic direction of the modifications across the CUSC
- Your recommendations (part of the decision making process on self-governance) will be directly fed through to the Authority when they are making decisions
- CUSC Panel Members and Alternate Members must act impartially and not as a representative or in the interest of a company or person they are employed by
- The Term of Office last two years – the current CUSC Panel Members' term of office expires 30 September 2017

# What positions are available

---

## ■ Membership:

- **Appointed: One Independent Chair, two National Grid representatives, one Consumer Representative (from Citizens Advice or the Citizens Advice Scotland), and a Panel Industry Secretary.**
  - **Additionally one OFGEM representative is entitled to attend Panel meetings as an observer**
- **Elected: up to seven elected industry members (and up to five alternate members), the current elected CUSC Panel:**
  - **Paul Jones, Uniper**
  - **Garth Graham, Scottish & Southern Energy plc**
  - **Simon Lord, Engie**
  - **Paul Mott, EDF Energy**
  - **James Anderson, Scottish Power Energy Management**
  - **Kyle Martin, Energy UK**
  - **Cem Suleyman, Drax**

Users may appoint up to 5 Alternate Members at the same time as Panel members are appointed. Currently, there are none

# Who can be nominated to become a Panel Member?

---

- If you are on the CUSC Schedule 1 you will be provided with a form to put forward a nomination
- Note that even if you are not CUSC Schedule then you could be nominated by a company on CUSC Schedule 1
- Independent Chair
  - We are also going through the process of appointing the Independent Chair for the CUSC and Grid Code

## Process to be followed

---

- If less than 7 people are nominated they are automatically elected
- If more than 7 people are nominated, the full election process will be run in accordance with the timetable. The Code Administrator emails industry with a ballot paper informing them the election vote is open (1 vote per user). In order to vote they have to be a 'User' as detailed Schedule as at 20 June in that year.
- Voting will follow the process set out in Section 8 of the CUSC
  - Each CUSC User will have one voting paper each but can select up to three preferred candidates from the list on the voting paper, and rank them in order of preference (1, 2, 3). Voting papers all carry equal weight.

# Time commitments

---

- **The CUSC Panel meet monthly (last Friday of the month at National Grid's offices in Warwick).**
  - **Teleconference and WebEx facilities provided.**
- **Papers sent out 5 working days before the meeting and may involve varying degrees of complexity, depending on the issues or topics raised.**
- **Under certain circumstances, such as the Urgent modifications process, Special CUSC Panel meetings may be convened at short notice.**
- **Panel Members are expected to attend as many Panel Meetings as they can.**
- **Alternate Panel Members are elected to provide cover in the event that a Panel Member is unable to attend a meeting.**
  - **Alternate Panel Members are therefore encouraged to attend as many Panel meetings as they can, in order to keep up to date with Panel business and be in a position to provide cover.**
